End User License Agreement (EULA)

Important: This end user license agreement ("EULA") is a legal agreement between you (either an individual or an entity) and the author(s) of this software represented under the name "Chimoosoft". Read it carefully before using the software. It provides a license to use the software and contains warranty information and liability disclaimers. By installing, copying, or otherwise using the software, you agree to be bound by the terms of this agreement. If you do not agree to the terms of this agreement, do not install or use the software.

First, and foremost: Although our software is not known to cause any harm, *use it at your own risk*. We will not be held responsible for any damage that may happen to your computer or person as a result of using our software.

1. DEFINITIONS

- "**Chimoosoft**" refers to the developer(s) of this software.
- "**Software**" means the software program(s) supplied by Chimoosoft, and corresponding documentation, associated media, printed materials, and online or electronic documentation.
- "**Shareware**" in this context refers to a software program which is distributed without a fee and which the user is granted a free trial of. If the user plans to continue using the software and would like to remove the startup delay, they must purchase a license key from Chimoosoft.
- "**Freeware**" refers to fully functional software which is distributed for free with no donation expected (although still welcomed).
- "**User**" refers to the individual or entity who either purchases the license key (for shareware) or uses the software (freeware).

2. GRANT OF LIMITED LICENSE

- **Installation and Use of Freeware.** If the software is distributed as freeware, you may install and use ("run") as many copies of the software on as many computers as you like.
- **Installation and Use of Shareware.** If the software is shareware (such as Terrabrowser), you may only use the provided registration number (license key) on up to five (5) computers in your household for personal use. 3. LICENSE RESTRICTIONS

- **Distribution.** You may not distribute copies of the software or the license key to

third parties. You are responsible for not distributing your license key (registration number) which contains your name within it.

- **Reproduction.** Except for backup and installation purposes the software must not be reproduced on any type of media (including, but not limited to, CD-ROM, DVD or internet download) without prior email approval from Chimoosoft. We will be happy to grant you this approval but would like to keep track of where our Software ends up.
- **Prohibition on Reverse Engineering, Decompilation, and Disassembly.** You may not reverse engineer, decompile, or disassemble the Software, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.
- **Rental.** You may not rent, lease, or lend the software or otherwise encumber any copy of the software, or any of the rights granted herein.

This EULA shall continue for as long as the software is used according to the terms of this agreement.
